Hard and Porous Surface Graffiti Removers

Removing graffiti has never been easier! Remove unwanted graffiti, marker and other "tags" from concrete and block surfaces, lockers, road signs, rail cars and anywhere else graffiti is found. Maintain original appearances without the need for repainting.

Hard Surface Graffiti Remover

Application: (1) Use a plastic drop cloth to protect surrounding areas and/or landscaping. If indoors, open windows or use a fan to maintain ventilation of the work area. (2) Test product on a small, inconspicuous area before beginning the full project. (3) Spray **Hard Surface Graffiti Remover** onto surface and gently rub with paper towel, cloth or scrub pad. Most graffiti will begin to lift from surface within minutes. (4) If ghosting remains, repeat the process.

Clean Up: Use **BLUE BEAR® Emerge™ Cleaner & Degreaser** or soap and water with a paper towel, cloth, scrub brush or mop to clean remaining residue.

Safe for use on: Metal, glass, painted wood surfaces and some non-reflective traffic signs.

Do not use on: PVC, drywall, limestone, terrazzo tile, rubber, plexiglass or other clear acrylic sheets.

Precautions: Concrete surfaces may darken with use of **Hard Surface Graffiti Remover**. Protect plants and vegetation with a plastic drop cloth. Always use care to prevent overspray from getting on surfaces other than the one being prepped or cleaned. Avoid contact with eyes and skin. In case of contact with eyes or skin, flush thoroughly with water. Wear safety glasses to prevent product overspray from resulting in possible eye irritation, chemical-resistant gloves to protect from skin irritation and dryness, and work-appropriate shoes. Keep container closed when not in use.

Porous Surface Graffiti Remover

Application: (1) Test on a small, inconspicuous area before beginning the full project. (2) **Spray Porous Surface Graffiti Remover** and allow to sit for a few minutes. Use either a stiff, natural bristled brush or a metal brush to agitate. (3) Wait until paint starts to buckle or lift before power washing. Heavier coatings may require reapplication of product before power washing. (4) Repeat entire process if necessary.

Clean Up: Use **BLUE BEAR® Emerge™ Cleaner & Degreaser** or water and a scrub brush or power washer to clean remaining residue.

Safe for use on: Concrete, brick, stone, landscaping block, bare brick

Do not use on: PVC, drywall, limestone, terrazzo tile, rubber, plexiglass or other clear acrylic sheets

Precautions: Concrete surfaces may darken with use of **Porous Surface Graffiti Remover**. Protect plants and vegetation with a plastic drop cloth. Always use care to prevent overspray from getting on surfaces other than the one being prepped or cleaned. Avoid contact with eyes. In case of contact with eyes, flush thoroughly with water. Avoid prolonged contact with skin. Wear safety glasses to prevent product overspray from resulting in possible eye irritation, chemical-resistant gloves to protect from skin irritation and dryness, and work-appropriate shoes. In poorly ventilated or non-ventilated areas, use of a NIOSH certified (or equivalent) organic respirator is recommended.
